## **Non-Civil Service Vacancy**

Hair Dresser (Production Services Division – Art Services (Art & Image Design Section)) (Salary: \$15,410 per month)

**Entry Requirements :** Candidates should have –

- (i) a Hong Kong degree in Theatre / Entertainment Arts or related studies, or equivalent; and 1 year's hairdressing experience; OR
- (ii) an accredited Higher Diploma or an accredited Associate Degree in Theatre / Entertainment Arts or related studies from a Hong Kong tertiary institution, or equivalent; and 2 years' relevant experience; OR
- (iii) at least 8 years' relevant experience.

Candidates who possess –

- (i) hairdressing experience relating to TV / Film production or stage performance; and / or
- (ii) good spoken English and Putonghua and able to handle Chinese and English correspondences

will have an advantage.

(Note: Candidates are required to sit for a trade test.)

**Duties :** To undertake day-to-day duties relating to (a) designing and setting different styles of hairdressing arrangements; (b) advising producers on the hairdressing styles for specific programme requirements; (c) assisting in purchasing and hiring of the required equipment and helpers for the Hairdressing Team; and (d) assisting in undertaking administrative and operational duties as assigned by supervisors. (Note: Required to work irregular hours / over-night shifts / on public holidays.)

**Terms of Appointment & Fringe Benefits :** Successful candidate will be appointed on one-year non-civil service contract terms. If the contract is satisfactorily completed with consistently high standard of performance and conduct, the officer may be granted a gratuity which, when added together with the Government's contribution to MPF scheme, equals 15% of the total basic salary drawn during the contract period. Rest day, general holidays, annual leave, maternity leave, sickness allowance, where appropriate, will be granted on terms not less favourable than the provisions in the Employment Ordinance.

**How to Apply :** Application forms (G.F. 340 (Rev. 3/2013)) are obtainable from any Public Enquiry Service Centres of District Offices, Home Affairs Department or any Job Centres of the Employment Services Division of Labour Department. ## **General Notes:**

- (A) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise.
- (B) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirements irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race.
- (C) Non-civil service vacancies are not posts on the civil service establishment. Candidates appointed are not on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will not be eligible for posting, promotion or transfer to any posts in the Civil Service.
- (D) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made.
- (E) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend recruitment examination and/or interview.
- (F) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he/she will be invited to attend the selection interview/written examination without being subject to any further shortlisting criteria.
- (G) Holders of academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority may also apply but their qualifications will be subject to assessments on equivalence with the required entry qualifications. They should submit copies of their official transcripts and certificates by mail to the above enquiry address.
