Non-Civil Service (Programme) Vacancy

Part-time Hairdresser

(Image Design Section, Production Services Division)

Salary: \$116 per hour

Entry Requirements: Candidates should have –

- (a) (i) a Hong Kong Bachelor's degree in Theatre / Entertainment Arts or related discipline, or equivalent; and 1 year's relevant experience in hairdressing; **OR** (ii) an accredited Associate Degree or an accredited Higher Diploma in Theatre / Entertainment Arts or related discipline, from a Hong Kong tertiary institution, or equivalent; and 3 years' relevant experience in hairdressing; **OR** (iii) Level 2 or above in Chinese Language and English Language together with 3 other subjects at Level 2 or equivalent or above in the Hong Kong Diploma of Secondary Education Examination (HKDSEE), or equivalent [See note (1)]; and 8 years' relevant experience in hairdressing; **OR** (iv) Level 2 or above in Chinese Language and English Language together with 3 other subjects at Grade E or above in the Hong Kong Certificate of Education Examination (HKCEE), or equivalent [See note (2)]; and 8 years' relevant experience in hairdressing; **AND**
- (b) Level 2 or above in Chinese Language and English Language in the HKDSEE or HKCEE, or equivalent [See note (2)].

[**Note:** (1) “Attained” in Applied Learning subjects (subject to a maximum of two Applied Learning subjects), and Grade E in other language subjects in the HKDSEE are accepted as equivalent to Level 2 in the New Senior Secondary subjects in the HKDSEE. (2) “Grade E” in Chinese Language and English Language (Syllabus B) in previous HKCEE are accepted administratively as comparable to “Level 2” in Chinese Language and English Language in the 2007 HKCEE and henceforth. (3) Candidates may be required to sit for a trade test. (4) Hairdressing experience relating to TV/Film production or stage performance is a definite advantage. (5) Candidates should provide documentary proofs of their relevant qualifications and experience for assessment.]

Duties: Designing and setting different styles of hairdressing to meet production requirements; creating special hairdressing effects; maintaining the continuity of hairdressing and special effects on performers; removing special hairdressing effects; and assisting in other duties as assigned.

[**Note:** (i) The number of working hours is subject to the prevailing operational needs. No guarantee on the minimum hours of work in any given period. Working time per week will be less than 18 hours. Successful candidate will be assigned to work outdoor, irregular hours and on Sundays and Public Holidays as well as to perform overnight duties. (ii) Part-time Hairdresser will not be entitled for meal breaks or late night travelling expenses.]

Terms of Appointment: Successful candidate will be appointed on non-civil service contract terms for not more than 12 months. Working time per week will be less than 18 hours. He/She will be required to work on an as and when required basis.

Completed forms should be sent to the address below by post or by hand on or before the closing date for application. For submissions by post, applicants should ensure that the correct address is clearly printed or written on the envelope and sufficient postage is paid. An applicant will bear any consequences arising from not paying sufficient postage. The postmark date on the envelope will be regarded as the date of submission of application. Please specify the post of application on the envelope. For submissions by hand, completed application forms should reach the below address during office hours (Monday to Friday 8:45 a.m – 6 p.m. Lunch break 1 p.m. – 2 p.m.). Applications which are late, incomplete, submitted by fax or by e-mail or not made in the prescribed form will NOT be considered. Candidates who are selected for interview will normally receive an invitation in about 8 weeks from the closing date for application. Those who are not invited for interview may assume that their applications are unsuccessful. Only shortlisted candidates will be notified.

General Notes:

- (A) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise.
- (B) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirements irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race.
- (C) Non-civil service vacancies are not posts on the civil service establishment. Candidates appointed are not on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will not be eligible for posting, promotion or transfer to any posts in the Civil Service.
- (D) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made.
- (E) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend recruitment examination and/or interview.
- (F) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he/she will be invited to attend the

selection interview/written examination without being subject to any further shortlisting criteria.

- (G) Holders of academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority may also apply but their qualifications will be subject to assessments on equivalence with the required entry qualifications.
