Non-Civil Service Vacancy

Videographer (Electronic Field Production & Photography Section, Production Services Division)

(Salary: \$17,685 per month)

Entry Requirements: Candidates should have -

- (a) (i) an accredited associate degree or an accredited higher diploma, from a Hong Kong tertiary institution, or equivalent; and 2 years' relevant experience in filming, lighting or sound recording for TV/film production; OR
 - (ii) an accredited diploma, from a Hong Kong tertiary institution, or equivalent; and 4 years' relevant experience in filming, lighting or sound recording for TV/film production; OR
 - (iii) Level 3 or equivalent [See Note (1)] or above in 5 subjects in the Hong Kong Diploma of Secondary Education Examination (HKDSEE) (which may include Chinese Language and English Language), or equivalent; or Grade E or above in 2 subjects at Advanced Level in the Hong Kong Advanced Level Examination and Level 3/Grade C or above in 3 other subjects in the Hong Kong Certificate of Education Examination (HKCEE) (which may include Chinese Language and English Language), or equivalent; and 5 years' relevant experience in filming, lighting or sound recording for TV/film production; OR
 - (iv) Level 2 or equivalent [See Note (1)] or above in 5 subjects including Chinese Language and English Language in HKDSEE, or equivalent; or Level 2/Grade E or above in 5 subjects including Chinese Language and English Language in HKCEE, or equivalent; and 6 years' relevant experience in filming, lighting or sound recording for TV/film production; AND
- (b) met the language proficiency requirements of Level 2 or above in Chinese Language and English Language in the HKDSEE/HKCEE, or equivalent [See Note (2)].

Candidates who possess experience in operating lighting equipment, audio equipment and/or video camera for drama, news and documentary programme production will have an advantage.

[Notes:

- (1) "Attained with Distinction" in Applied Learning subjects (subject to a maximum of two Applied Learning subjects), and Grade C in Other Language subjects in HKDSEE are accepted as equivalent to Level 3 in the New Senior Secondary subjects in HKDSEE. "Attained" in Applied Learning subjects (subject to a maximum of two Applied Learning subjects), and Grade E in Other Language subjects in HKDSEE are accepted as equivalent to Level 2 in the New Senior Secondary subject as equivalent to Level 2 in the New Senior Secondary subjects are accepted as equivalent to Level 2 in the New Senior Secondary subjects in HKDSEE.
- (2) "Grade C" and "Grade E" in Chinese Language and English Language (Syllabus B) in previous HKCEE are accepted administratively as comparable to "Level 3" and "Level 2" respectively in Chinese Language and English Language in the 2007 HKCEE and henceforth.
- (3) Candidates may be required to sit for a trade test.]

Duties: (a) Work mainly as Videographer of a crew for Drama, News and Documentary production; (b) carry out duties of lighting setup for TV production; (c) perform video shooting and sound recording on-location; (d) assign tasks to general assistants/other colleagues; and (e) undertake other tasks as assigned. (Note: Successful candidate may be required to work irregular hours.)

Terms of Appointment & Fringe Benefits: Successful candidate will be appointed on one-year non-civil service contract terms. If the contract is satisfactorily completed with consistently high standard of performance and conduct, the officer may be granted a gratuity which, when added together with the Government's contribution to MPF scheme, equals 15% of the total basic salary drawn during the contract period. Rest days, general holidays, annual leave, maternity leave, paternity leave, sickness allowance, where appropriate, will be granted on terms not less favourable than the provisions of the Employment Ordinance.

Those who are not invited for interview may assume that their applications are unsuccessful. Only shortlisted candidates will be notified.

- (A) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise.
- (B) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirements irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race.
- (C) Non-civil service vacancies are not posts on the civil service establishment. Candidates appointed are not on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will not be eligible for posting, promotion or transfer to any posts in the Civil Service.
- (D) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made.

- (E) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend recruitment examination and/or interview.
- (F) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he/she will be invited to attend the selection interview/written examination without being subject to any further shortlisting criteria.
- (G) Holders of academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority may also apply but their qualifications will be subject to assessments on equivalence with the required entry qualifications.
