Non-Civil Service (Programme) Vacancy

**Temporary Assistant Producer (General, Dubbing Stream) / Acquisition Section,
TV Division**

Salary: HK\$10,500 – \$13,500 per month (salary depending on qualification and experience)

Entry Requirements: Candidates should have (a) (i) a Hong Kong degree, preferably in Journalism & Communication, or equivalent; OR (ii) an accredited Higher Diploma or an Associate Degree, preferably in Journalism & Communication, or equivalent; and 1 year's TV production experience; OR (iii) 3 years' relevant experience; AND (b) Level 2 or above in Chinese Language and English Language in the HKDSEE or HKCEE, or equivalent [See note (1)].

(Note: (1) "Grade E" in Chinese Language and English Language (Syllabus B) in previous HKCEE are accepted administratively as comparable to "Level 2" in Chinese Language and English Language in the 2007 HKCEE and henceforth (2) Candidates may be required to submit their previous productions to demonstrate their production skills and / or sit for a trade test.)

Duties: Assisting in (a) conducting research; (b) liaising with different parties such as outside parties, interviewees, artistes, participants for programme production / event / project / contest; (c) planning and designing programme / event / project / contest contents; (d) working out production and post-production details; (e) providing various / administrative / logistics support related to programme production / event / project / contest. (Note: Required to work irregular hours and on Sundays and Public Holidays as well as to perform overnight shift duties.)

Terms of Appointment & Fringe Benefits: Successful candidate will be appointed on short-term non-civil service contract terms for not more than 1 year. Rest days, general holidays, annual leave, maternity leave, sickness allowance, where appropriate, will be granted in line with the provisions of the Employment Ordinance.

How to Apply: Application forms (G.F. 340 (Rev.3/2013)) are obtainable from any Public Enquiry Service Centres of District Offices, Home Affairs Department or any Job Centres of the Employment Services Division, Labour Department. Completed forms should be sent to the address below on or before the closing date for application. Please mark on the envelope "Application for the position of Temporary Assistant Producer (General, Dubbing Stream)". Applications not made in the prescribed form or which are incomplete, late or without required photocopies of the above documents will not be considered. Candidates who are selected for interview will normally receive an invitation in about 8 weeks from the closing date for application. Those who are not invited for interview may assume that their applications are unsuccessful. Only shortlisted candidates will be notified.

General Notes:

(A) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise.

(B) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirement irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race.

(C) Non-civil service vacancies are not posts on the civil service establishment. Candidates appointed are not on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will not be eligible for posting, promotion or transfer to any posts in the Civil Service.

(D) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made.

(E) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend recruitment examination and/or interview.

(F) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he/she will be invited to attend the selection interview/written examination without being subject to any further shortlisting criteria.

(G) Holders of academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority may also apply but their qualifications will be subject to assessments on equivalence with the required entry qualifications. They should submit copies of their official transcripts and certificates by mail to the above enquiry address.
